Bill Payment Information

Payments and Penalties:

Sewer service charges shall be due on the date so indicated on the monthly statement. A late payment charge of 1 percent per month will be added to bills not paid within 20 days of issuance. This late payment charge will be applied to the total unpaid balance for utility service, including unpaid late payment charges. The late payment charge is applicable to all customers. Failure to receive a bill shall not exempt or excuse the consumer from the obligation to pay for the service rendered.
